

**RELEASE OF LIABILITY
ASSUMPTION OF RISK AND ACKNOWLEDGEMENT OF HAZARD**

I the undersigned, acknowledge and agree that participating in any way in the GIBRALTAR CLIMBING COMPANY program, related events and activities has INHERENT RISKS. THOSE RISKS INCLUDE BUT ARE NOT LIMITED TO:

1. Injuries resulting from myself falling, including but not limited to, falling into other persons, falling and coming into contact with any walls, structures or ropes, or falling to the floor, whether accidental or related to bad belaying.
2. Injuries' resulting from the fall of other persons, or objects such as broken holds, that may come in contact with me.
3. Injuries that occur from NEGLIGENCE or lack of adequate training.
4. Injuries or death resulting from the failure or negligent misuse of the facilities, climbing walls or equipment of the GIBRALTAR CLIMBING COMPANY.
5. Injuries or death resulting from the failure of equipment, or poor design or placement of any equipment, including but not being limited to ropes, carabiners, quick draws, bolt hangers, and all anchors, except in the case of gross negligence.

I understand that instructions given to me by staff members of GIBRALTAR CLIMBING COMPANY, may be important for my safety, and I agree to follow all such instructions, and to ask for assistance if I do not understand such instructions. I warrant that the information provided on the "Registration Form" is accurate.

I ASSUME COMPLETE RESPONSIBILITY for those risks and for the injuries that may occur as a result of those risks EVEN IF injuries occur in a MANNER that is NOT FORESEEABLE at the time I sign this agreement. I realize that by voluntarily assuming the risks involved, I will be SOLELY RESPONSIBLE for any loss or damage I sustain, including PERSONAL INJURIES to me, damage to my property or damage arising out of death.

I am aware of these and numerous other inherent risks in observing or participating in the activities offered and/or sponsored by GIBRALTAR CLIMBING COMPANY. On behalf of myself, my family, executors, heirs, and administrators, I willingly and knowingly ASSUME COMPLETE RESPONSIBILITY for all risk of physical injury in any way related to my activities and I hereby release GIBRALTAR CLIMBING COMPANY LTD. It's directors, owners, employees, volunteers, contracted staff and landlords from any and all liability arising out of my use of the facilities of GIBRALTAR CLIMBING COMPANY LTD.
